9. BUSINESS

9.1 RECREATION ISSUES

Mrs. Nicole Bizzaro advised that the two AmeriCorps employees currently at the Recreation Department are subject to a thirty-day suspension as the funding agency Plus-Time has closed. She advised that after reviewing the funds available they are able to offer the employees $18\frac{1}{2}$ hours per week for the thirty-days or until another agency is contracted under Volunteer NH. Selectman Gilbert asked the amount of money owed to the Town by Plus-time. Mrs. Bizzaro advised they owe around \$2,300.00. Selectman McGeough requested Town Administrator Shankle contact the Attorney General to see if they are aware of the issue and advise the classification of the company.

Mrs. Bizzaro provided a draft of the proposed Recreation Sign. Town Administrator Shankle advised that the wording should be sent to the Recreation Commission.

Motion by Selectman Gilbert to propose the wording on the sign be 'Epping Recreation Center'. Seconded by Selectman McGeough. Motion carried 4-0.

9.2 PURCHASE ORDER – International Salt

Purchase order for International Salt in the mount of \$16,776.00 for 300 tons of salt was submitted for approval.

Mr. Dave Reinhold advised that the new purchase order policy requires approval by the Board and asked what to do if salt is needed in an emergency.

Motion by Selectman McGeough to request Town Administrator Shankle approve any emergency purchases and advise the Board via e-mail. Seconded by Selectman Jordan. Motion carried 4-0.

Selectman McGeough asked if the Highway Department had ever used Magic Salt. Mr. Reinhold advised that they utilize it in certain areas in Town but not on the roadways.

Selectman McGeough requested consideration to reverse the motion to cut surplus wood at the Transfer Station and make it available to residents. He stated that the distribution of the wood would be an issue and suggested a lottery or a procedure to fairly distribute the wood be developed. Mr. Reinhold advised that the wood would not be able to be burnt until next year. Town Administrator Shankle requested the wood be held until the procedure is in place for distribution.

Motion by Selectman McGeough to remove the previous motion to cut up and place surplus wood at the Transfer Station for residents pending the development of a procedure approved by the Board. Seconded by Selectman Gilbert. Motion carried 4-0.

Mr. Reinhold advised that one employee would be leaving at the end of the month and requested approval to hire two part time employees until the spring.

10. CORRESPONDENCE & REPORTS

10.1 TOWN ADMINISTRATOR REPORT

Town Administrator Shankle stated that the Budget Hearing is scheduled for Wednesday night at 6:30 PM. Also, a tentative Board Meeting is scheduled for Wednesday in case any petition warrant articles are submitted.

Town Administrator Shankle submitted a Raffle Request from St. Joseph's Church to hold a raffle from February 13 through July 3, 2011.

Motion by Selectman McGeough to approve the Raffle Request for St. Joseph's Church. Seconded by Selectman Gilbert. Motion carried 4-0.

Town Administrator Shankle advised that the recent Town Revaluation by Vision Appraisal was completed three months later than the contract specified and incurred a \$100.00 per day penalty. Vision has proposed to compensate for the delay by providing one year free maintenance and two years web hosting at no charge to the Town. Judith Bielecki advised that the proposal totals approximately \$11,000.00 and covers the \$9,000.00 penalty.

Motion by Selectman Gilbert to accept the proposal from Vision Appraisal to provide one year free maintenance, and two years of free webhosting in lieu of the \$9,000.00 penalty. Seconded by Selectman McGeough. Motion carried 4-0.

Town Administrator Shankle advised that a letter of interest to join the Recreation Commission by Tony Loving. The letter stated that Mr. Loving would like to be appointed as his wife would be resigning.

Motion by Selectman Gilbert to approve the appointment of Mr. Loving to the Recreation Commission subject to the resignation of Mrs. Loving. Seconded by Selectman Jordan. Motion carried 4-0.

10.2 INDIVIDUAL SELECTMEN'S REPORTS

Selectman Jordan

Selectman Jordan advised that residents have been expressing apprehension about the pan-handler at the entrance to the plaza at Wal-Mart. Selectman Archambault requested an ordinance be written in this regard. Selectman Gilbert asked Town Administrator Shankle to contact LGC about this issue.

Selectman McGeough

Selectman McGeough asked about the pending storm and whether the dump would be closed. Town Administrator Shankle suggested consideration of a policy whereby if the schools are closed the transfer station would be closed. Selectman McGeough requested that Channel 9 be contacted if it is closed. He suggested the Highway Department be contacted to develop a policy.

Selectman McGeough advised that there is a Budget Committee Meeting on Wednesday and the Public Hearing is Saturday starting at 9:00 AM.

Selectman McGeough stated that the tragedy in Arizona is a shame with the loss of a young child, a Federal Judge, and the

shooting of the Congresswoman and others. He added that violence is wrong and a nine year old trying to learn about politics was gunned down trying to learn about government.

Selectman Gilbert

Selectman Gilbert asked about the Town's financial position at the end of the year. Town Administrator Shankle stated that Finance will advise.

Selectman Gilbert asked about the status of an explanation of the assessment on property owned by the Cloutier's.

Selectman Archambault

Selectman Archambault advised that the pending snow storm looks like it will be substantial and the Town is prepared and we also have a capable Emergency Management Director, Tim Flowers.

11. COMMENTS BY VISITORS

Mr. Paul Spidle stated that if the Budget Committee Meeting is cancelled what would be available to get the word out. Town Administrator Shankle advised that he should contact him and he would contact ETV and Channel 9. He advised that the Budget Committee Hearing is 9:00 AM on Saturday and residents should attend to make their feelings known.

7:30 PM - Building Permit on Class VI Road – Cantichi

Mr. Cantichi addressed the Board for an answer to a request to build a home on Birch Hill Road. Selectman McGeough stated that the road was closed due to Town Vote and did not want to grant the request unless it was voted on. Mr. Cantichi advised that the road was not closed and the lot is buildable and would improve the road for access. He added that an agreement could be prepared by the lawyer to address any outstanding issues. Selectman Gilbert asked if he would be coming in from Route 87. Mr. Cantichi stated yes and would improve the road. Selectman Gilbert asked the classification of the road be reviewed. Town Administrator Shankle stated that the road classification will be reviewed for discussion at the next meeting.

Motion by Selectman Jordan to table until the next Board Meeting. Seconded by Selectman Gilbert. Motion carried 4-0.

12. ADJOURN

Motion by Selectman Gilbert to adjourn. Seconded by Selectman McGeough. Motion carried 4-0.
